INTRODUCTION

INTRODUCTION TO THE NRF

The National Research Foundation Act, Act 19 of 2018, establishes the National Research Foundation (“NRF”) as the juristic legal entity that will contract with the awarded bidder. The NRF supports and promotes research and human capital development through funding, the provision of National Research Facilities and science outreach platforms and programmes to the broader community in all fields of science and technology, including natural science, engineering, social science and humanities. INTRODUCTION TO THE BUSINESS UNIT

The South African Radio Astronomy Observatory (SARAO) is a National Facility of the National Research Foundation (NRF) housing and operating South Africa’s national radio telescope shared facilities including the MeerKAT and KAT-7 telescopes in the Karoo in the Northern Cape; the Hartebeesthoek Radio Astronomy Observatory (HartRAO) in Gauteng; and the African Very Long Baseline Interferometry (AVN) programme in nine African countries. SARAO manages the associated human capital development and commercialisation endeavours of government’s investment in astronomy. SARAO has offices based in Johannesburg and Cape Town, as well as the radio-protected Square Kilometre Array (SKA) host site in the Karoo, 90km from Carnarvon in the Northern Cape, which hosts the SKA mid-frequency telescopes, MeerKAT, and KAT-7 radio telescope installations, as well as a number of guest instruments, including the HERA telescope. CONTEXT OF THIS PROCUREMENT NEED

HartRAO has a few radio telescopes on site which are used for astronomy and geodetic VLBI. These telescopes are involved in 24hr observation sessions and are required to run continuously. The latest addition is a fast slewing VGOS radio telescope to be used for geodetic VLBI. The VGOS network of radio telescopes located all around the world will improve the accuracy of the Earth Orientation Parameters and the associated Celestial and Terrestrial Reference Frames which are used to accurately position e.g. radio telescopes on Earth and accurately point any telescope or array of telescopes at a target. Improved Earth Orientation Parameters and reference frames in turn will allow better pointing accuracy on the SKA dishes and global navigation systems.

In order to do this the VGOS antenna must be equipped with a broadband receiver, signal chain, digital backend and recorder capable of sampling and recording the bands of interest in real-time. The RF signals, up to 18 GHz, will need to be converted and transmitted over optical fibre to the control room where it will be digitised and recorded.

This tender is for the procurement of suitable Radio Frequency over Fibre transmitter and receiver modules to convert the signal for transfer over fibre optic and converting it back to be input into the digitiser unit.

PART A - CONTRACT

EQUIPMENT AND SERVICE SPECIFICATION

Equipment

1. Five Radio Frequency over Fibre transmitters (including pre and/or post amplifiers if necessary to achieve specifications) and
2. Five Radio Frequency over Fibre receivers (including pre and/or post amplifiers if necessary to achieve specifications)

The transmitters and receivers must meet the following specifications:

- Input Voltage: 230VAC or Standard 5, 12 or 15 VDC
- Frequency Range: 1 GHz – 18 GHz
- RF Gain: > 15 dB in the 1 – 14 GHz range
- Gain flatness: < ± 3 dB peak-peak
- Noise Figure: < 20 dB over the entire range
- SFDR: ≥ 100 dB
- P1dB (input): -13 dBm or better
- VSWR: 2:1 (maximum)
- Input/Output impedance: 50 Ω
- RF Input/Output Connectors: SMA
- Optical Connectors: FC/APC
- Communications/monitoring: Ethernet or serial communications

Services

1 Supplier Relationship Management

- 1.1 The appointed bidder shall manage the supply relationship between SARAO and the OEM.
- 1.2 Where funding is available, SARAO shall acquire, through the appointed bidder, additional hardware for the VGOS receiver signal chain.
- 1.3 SARAO, upon agreement, confirms the negotiated pricing and delivery dates through the issue of a written purchase order that specifies this contract number, the purchase order number, delivery date, description, and unit price as SARAO will only place purchase orders where funding has been made available.

2 Delivery service

- 2.1 Procured items shall be delivered within the period stipulated on the issued purchase order with the maximum allowable period being within twelve (12) weeks of receipt of purchase order by the appointed bidder.

3 Packing

- 3.1 The appointed bidder shall have the items securely packaged to protect the contents from physical damage during transportation to site.

4 Delivery and documentation

- 4.1 All items shall be delivered with specification sheets, original delivery note, original invoice, calibration certificates or factory tests and instruction/service manual/datasheet.
- 4.2 All documentation shall quote contract number and purchase order number.

5 Insurance

5.1 The appointed bidder carries insurance of at least R 2 million for public liability, product liability, and professional indemnity.

6 Transportation

6.1 Transfer of ownership will happen when the equipment is delivered and accepted at the Hartebeesthoek Radio Astronomy Observatory of SARAO in Hartebeesthoek, Krugersdorp.

6.2 The appointed bidder shall include the transport cost in the total cost of the order.

7 Incidentals

7.1 The incidentals to this contract include, as a minimum, cabling, technical support, AC to DC power supplies, and 19" rack mount chassis, where applicable.

8 Validity of instructions

8.1 SARAO instructions shall be confirmed valid, through the issue of a written purchase order that specifies quantity, description, unit price, delivery date, contract number, and purchase order as a minimum.

9 Contract manager

9.1 The appointed bidder shall provide the name and contact details of their contract manager upon signing the contract to SARAO.

9.2 SARAO's contract manager is:

9.2.1 Philip Mey

9.2.2 Contact details shall be provided to the appointed bidder.

9.3 Where either party changes the contract manager, they shall advise the other party within five (5) working days.

9.4 The appointed bidder at all times shall receive instructions from the SARAO's contract manager.

10 Payment

10.1 SARAO shall make payment within thirty (30) days from the receipt of original invoice accompanied by the appointed bidder and SARAO's contract manager signed delivery performance documentation with the unit pricing in agreement with the respective purchase order issued in terms of the contract.

10.2 All documentation shall state the contract number, the purchase order number of the purchase order issued in terms of the main contract, detailed line item as specified in purchase order, and the reference to approved Certificate of Conformance.

10.3 It is in the interests of the appointed bidder to adhere to the above clauses 10.1 and 10.2 to receive prompt payment. Any losses incurred through exchange rate variations or interest charged on late payment shall be charged to the appointed bidder where these costs arose from non-adherence to the above.

11 Service provider's ability to deliver the contract

11.1 The bidder shall provide a minimum of three (3) written references within the last three (3) years from previous clients to whom they have supplied RFoF transmitters or receiver units. Bidders shall provide reference letters using their own template but shall address the risks set out in the reference letter template on page 32 of this bid document. Where bidders do not provide reference letters, the bidders shall provide the contact details for SARAO to conduct due diligence. SARAO

shall conduct telephonic due diligence utilising the same reference template provided on page 32 of this bid document to confirm that the bidders can meet these minimum risk requirements “meet requirements”.

11.2 The bidder should have a history of providing RfOF units and have been in business for at least 5 years.

12 Ethical requirements

12.1 The appointed bidder shall have no undue interests with the NRF, a record of complete honesty and ethical SCM practise, and has determined its bid independently from others as reflected on its submitted SBD 1, SBD 4, SBD 8, and SBD 9

13 Contract due diligence during the contract period

13.1 SARAO has the right to conduct supply chain due diligence including site visits and inspections at any given time during the contract period.

14 Managing service levels

14.1 Upon appointment, the appointed bidder and SARAO’s contract manager shall review the initial service levels as set out in this document supports the contract delivery.

14.2 Both parties shall agree on the final set of service levels including measurable key performance indicators with minimum thresholds in writing which is appended to this contract document.

14.3 The service levels shall be reviewed after the first three months against the experienced requirements of the contract.

14.4 Where both parties agree to variation of these service levels, both parties shall meet and agree on the revised service levels in writing which is appended to this contract document.

14.5 The agreed service level document shall state the agreed service levels, date effective from, performance penalties, and any matter forming part of such service levels.

14.6 The appointed bidder and SARAO’s contract manager shall measure delivered performance against the service levels as agreed in accordance with this document.

14.7 SARAO, through the signed contract, guarantees its procurement in terms of this contract from the appointed bidder only where the appointed bidder meets or exceeds the contractual performance levels.

14.8 Management of poor performance:

14.8.1 Where either party has identified poor performance under this contract, both parties shall meet and investigate the matter to determine the root cause.

14.8.2 Both parties shall agree to a correction plan and shall implement it.

14.8.3 Both parties shall monitor the corrective actions to ensure service levels are at the agreed minimum.

14.8.4 Both parties shall assess the applicability of penalties to the incurred poor performance and apply these.

14.8.5 The service performance levels are:

15 Communication

15.1 The contracted parties shall communicate in writing through mail, delivery, or email. The contracted parties shall state the contract number and purchase order number, if the latter is applicable, on communication documentation. The contract parties shall not act upon any communication without the contract number or must verify such communication with the business unit's contract manager prior to acting upon it.

16 Subcontract

16.1 Any sub-contract to another party complies with the requirements of the Preferential Procurement Policy Framework Act and its regulations.

17 Termination for default

17.1 In the event of the non-performance as per the agreed contract, the NRF shall appoint an alternative third party at the cost of the appointed bidder. The defaulting third party is obliged to settle the damages/additional costs that the NRF and its business units have incurred as result of their non-performance. The defaulting third party with the replacement third party shall set up a handover process that ensures continuity of service to the NRF.

18 Performance security

18.1 No performance security is required.

19 Occupational Health and Safety when working on NRF sites:

19.1 All personnel performing work on NRF site/s as part of this contract shall be required to undergo safety induction at the facility before they can start work.

19.2 Over and above the obligations provided by the Occupational Health and Safety Act (OHS Act No 85 of 1993 and its Regulations, known as 'the Act'), the appointed bidder shall comply with all relevant health and safety instructions as given to them by site safety personnel, where relevant. Personal protection equipment including closed safety shoes, hard hats, height safety equipment, and high visibility vests are worn at all times while on the work site. All personnel are to obey the relevant instructions, including signage, related to restricted access and speed limits on all sites.

19.3 The appointed bidder, upon signing the contract (SBD 7 and the NRF's Section 37.2 agreement), shall be responsible for itself, its employees, and those people affected by its operations in terms of the Act the regulations promulgated in terms thereof. The appointed bidder performs all work and uses equipment on site complying with the provisions of the Act.

19.4 The appointed bidder shall make available to the NRF on the valid Letter of Good Standing in terms

of the COID Act and ensures its validity does not expire while executing services the appointed bidder shall be awarded for this bid, where applicable. The appointed bidder shall furnish its registration number with the office of the Compensation Commissioner.

19.5 The appointed bidder shall maintain a health and safety plan complying with the requirements of The Act at the work site during the period that contracted work takes place on the site.

19.6 The NRF shall manage the appointed bidder in its capacity for the execution of this contract to meet the provisions of the said Act and the regulations promulgated in terms thereof. The appointed bidder shall accept liability for any contraventions to the Act. Each member of the appointed bidder's team (including sub-contracted personnel), shall submit a signed indemnity form prior to entering the work site and kept in the appointed bidder's health and safety file.

20 Copyright and Intellectual Property

20.1 Intellectual property refers to creations of the mind, such as inventions; literary and artistic works; designs; and symbols, names, images used in commerce; and includes copyright (a legal term describing the rights that creators have over their literary and artistic works including books, music, paintings, sculpture and films, to computer programs, databases, advertisements, maps and technical drawings); trademark (a legal term describing a sign capable of distinguishing the goods or services of one enterprise from those of other enterprises); and patents (a legal terms describing an exclusive right granted for an invention providing the patent owner with the right to decide how - or whether - the invention can be used by others).

20.2 Background intellectual property is defined as the intellectual property pertaining to this contract and created and owned by any of the contracted parties to this contract prior to the effective date of this contract.

20.3 Contract intellectual property is defined as intellectual property created by the parties to this contract for and in the execution of the contract.

20.4 All background intellectual property (existing prior to this contract) invests in and remains the sole property of the contracted parties to this contract. Both parties shall disclose openly such intellectual property ownership to the parties in writing at the commencement of this contract.

20.5 The contracted party shall grant the NRF a fully paid up, irrevocable, and non-exclusive licence to use its background intellectual property for the exploitation of this contract to enable the NRF to obtain the full benefit of the contracted deliverables for this contract.

20.6 The parties agree that all right, title, and interest in contract intellectual property created during the execution of this contract invests with the NRF unless where agreed in writing to a different allocation of the ownership of the contract intellectual property with such allocation being appendices to this contract.

20.7 Both parties to this contract shall keep the intellectual property created during this contract confidential and shall fulfil its confidentiality obligations as set out in this document.

20.8 The contracted party agrees to assist the NRF in obtaining statutory protection for the contract intellectual property at the expense of the NRF wherever the NRF may choose to obtain such statutory protection.

20.9 The contracted party shall procure where necessary the signatures of its personnel for the assignment of its respective contract intellectual property to the NRF or as the NRF may direct, and to support the NRF or its nominee, in the prosecution and enforcement thereof in any country in the world.

20.10 The contracted party shall irrevocably appoint the NRF to be its true and lawful agent in its

own name, to do such acts, deeds, and things and to execute deeds, documents, and forms that the NRF, in its discretion, requires in order to give effect to the terms of this clause.

21 Confidentiality

21.1 The recipient of confidential information shall be careful and diligent as not to cause any unauthorised disclosure or use of the confidential information, in particular, during its involvement with the NRF and after termination of its involvement with the NRF, the recipient shall not:

21.1.1 Disclose the confidential information, directly or indirectly, to any person or entity, without the NRF's prior written consent.

21.1.2 Use, exploit or in any other manner whatsoever apply the confidential information for any other purpose whatsoever, other than for the execution of the contract and the delivery of the deliverables or

21.1.3 Copy, reproduce, or otherwise publish confidentiality information except as strictly required for the execution of the contract.

21.2 The recipient shall ensure that any employees, agents, directors, contractors, service providers, and associates which may gain access to the confidential information are bound by agreement with the recipient both during the term of their associations with the recipient and after termination of their respective associations with the recipient, not to

21.2.1 Disclose the confidential information to any third party, or

21.2.2 Use the confidential information otherwise than as may be strictly necessary for the execution of the contract,

21.2.3 The recipient shall take all such steps as may be reasonably necessary to prevent the confidential information from falling into the hands of any unauthorised third party.

21.3 The undertakings set out in this clause shall not apply to confidential information, which the recipient is able to prove:

21.3.1 Was independently developed by the recipient prior to its involvement with the NRF or in the possession of the recipient prior to its involvement with the NRF;

21.3.2 Is now or hereafter comes into the public domain other than by breach of this contract by the recipient;

21.3.3 Was lawfully received by the recipient from a third party acting in good faith having a right of further disclosure and who do not derive the same directly or indirectly from the NRF, or

21.3.4 Required by law to be disclosed by the recipient, but only to the extent of such order and the recipient shall inform the NRF of such requirement prior to any disclosure.

21.4 The recipient shall within one (1) month of receipt of a written request from the NRF to do so, return to the NRF all material embodiments, whether in documentary or electronic form, of the confidential information including but not limited to:

21.4.1 All written disclosures received from the NRF;

21.4.2 All written transcripts of confidential information disclosed verbally by the NRF; and

21.4.3 All material embodiments of the contract intellectual property.

21.5 The recipient acknowledges that the confidential information made available solely for the execution of the contract and for no other purpose whatsoever and that the confidential information would not have been made available to the recipient, but for the obligations of confidentiality agreed to herein

21.6 Except as expressly herein provided, this contract shall not be construed as granting or

confirming, either expressly or impliedly any rights, licences or relationships by furnishing of confidential information by either party pursuant to this contract.

21.7 The recipient acknowledges that the unauthorised disclosure of confidential information may cause harm to the NRF. The recipient agrees that, in the event of a breach or threatened breach of confidentiality, the NRF is entitled to seek injunctive relief or specific performance, in order to obtain immediate remedies. Any such remedy shall be in addition to and not in lieu of any other remedies available at law, including monetary damages.

22 Protection of Private Information

22.1 The third party hereby gives the NRF permission, in terms of the Protection of Private Information Act 4 of 2013, to process, collect, receive, record, organise, collate, store, update, modify, retrieve, alter, consult, use, disseminate, distribute, merge, link, erase or destroy personal information received. By submitting a bid, the third party gives its voluntary explicit consent to the terms of this special condition.

23 Original bid documents for contract signing

23.1 Bidders must submit the specified original bid documents (including the bidder's response to the specification and the bidder's pricing) in hard copy format (paper document) to the NRF. This serves as the original master set annexed to the mandatory SBD 7 contract signing form creating the legal contract between the appointed bidder and the NRF. The master set remains at the NRF and has precedence over any other copies in the case of any discrepancies within the other sets of documents. The bidders attach the originals or certified copies of any certificates stipulated in this document to these original sets of bid documents. The signed legal contract constitutes the closure of the competitive bid/tender/request for quotation process and sets out each party's obligations for executing the contract.

CONTRACT PERIOD

None/Once-off. Only supply and delivery of equipment.

THE BIDDER SELECTION PROCESS

Stage 1 – Verification of the ability of a bidder to provide the services in accordance with specifications and conditions as set out in the bid documents.

Compliance to submission requirements

Bidders warrant that they can provide the goods and/or services in accordance with the specifications and conditions set out in this bid document. Bidders warrant that their bid document has as a minimum the specified documents required to verify their ability to deliver the specifications and conditions as set out in the bid documents. SARAO's evaluation committee disqualifies bidders where they do not provide the required documents, marked as mandatory (m), to verify their ethical conduct, the delivery of the specification, and their contract execution during the period of the contract.

Compliance to technical specifications

SARAO's evaluation committee disqualifies bidders when they are not compliant with the technical specifications as demonstrated by their own submitted documents.

Due Diligence Research

SARAO confirms the recommended bidder(s)'s reference letters with referees to confirm the recommendation(s). Where circumstances justifies it, the SARAO conducts interviews with bidders for them to clarify their bid

submission to the evaluation committee

Stage 2 – Price competition

Compliant bidders from the previous stage compete against each other on price at the stated minimum threshold level. SARAO's evaluation committee compares each bidder's pricing quote on an equal and fair comparison basis equitable to all bidders, taking into account all aspects of the bid's pricing requirements. SARAO's evaluation committee ranks the qualifying bids on points scored on the basis of both Price and B-BBEE as indicated on SBD 6.1 in accordance with the PPPFA.

Stage 3 – Award and contract signing

The bid evaluation committee recommends to its Delegated Authority the bidder with the highest combined score for the contract award subject to the final verification of the bidder's tax status as set out in the SBD 1 through the CSD and, for non-resident respondents, submits the SBD 1 questionnaire to obtain the Confirmation of Tax Obligations letter from the South Africa Revenue Services.

Cancellation of the bid prior to award

SARAO cancels this bid invitation prior to making an award where

- a) Due to changed circumstances there is no need for the specified procurement in the document, or
- b) No bids meet the minimum required specification, or a material irregularity occurred in the bid process, or
- c) Where the price is too low/high in comparison to the pre-bid defined market price range with no bidder prepared to negotiate the price into the determined market price range.
